SUBJECT: PRIMA FACIE VIOLATION OF THE MODEL CODE OF CONDUCT (MCC)
REGARDING ILLEGAL DISPLAY OF CAMPAIGN MATERIAL ON PUBLIC
PROPERTY.

Sir,

This Committee has taken on record photographic evidence captured on February 5, 2026, at 12:48 PM at 4828, Seelampur Rd, Gandhi Nagar, New Delhi 110053. The evidence clearly displays large-scale campaign posters and banners belonging to your respective candidatures fixed onto public civil structures.

The notification dated December 27, 2025, explicitly prohibits the "crude display of money power" and mandates upholding the "nobility and dignity of the legal profession". Furthermore, the BCD advisory dated November 3, 2025, specifically directed the immediate removal of hoardings, banners, and posters.

In exercise of the powers vested in the Election Committee and the Returning Officer to ensure a free and fair election, you are hereby called upon and directed to **APPEAR IN PERSON** for a **Summary Inquiry** at **4.00 P.M** on **06.02.2026** at the BCD Office situated at **1-F, Lawyer's Chambers, Delhi High Court, New Delhi** and explain as to why your candidature should not be **CANCELLED / NULLIFIED** immediately for this gross breach of the MCC and for attempting to vitiate the sanctity of the election process.
