**SUBJECT: NOTICE TO CEASE AND DESIST ABETMENT OF ELECTORAL MALPRACTICE AND VIOLATION OF MODEL CODE OF CONDUCT**

Sir/Madam,

It has come to our notice that your establishment is the scheduled venue for a gathering hosted by Mr. Ramit Sherawat, a candidate in the upcoming Bar Council of Delhi (BCD) Elections 2026, and/or his supporters, scheduled for this evening, February 4, 2026, from 6:00 PM to 9:00 PM.

Be advised that the Model Code of Conduct (MCC) governing these statutory elections strictly prohibits candidates/ their supporters from hosting, sponsoring, or organizing any event involving the provision of food, beverages, or hospitality to the electorate. Organizing such an event at a commercial bar/lounge for the purpose of electioneering is a grave violation of the rules laid down by the Election Committee and the Bar Council.

By providing your premises and services for this specific event, your establishment is effectively abetting a violation of the law and the ethical standards governing the legal fraternity.

You are hereby directed to:

Cease and Desist from hosting the aforementioned event or any gathering associated with the BCD Election canvassing by the said candidate/his supporters.

The inclusion of your establishment's management in legal proceedings related to the violation of the MCC.

A request for an inquiry into the financial transactions and billing for this event under election expenditure audit rules.

The Bar Council expects the cooperation of reputable establishments like yours in maintaining the integrity of the democratic process within the legal profession.

We hold the Bar Council of Delhi and its regulatory framework in the highest regard and have never intended to act in any manner that may violate its directions, rules, or the sanctity of the election process.

With reference to the contents of your letter, it is respectfully submitted that our office has no knowledge of any individual by the name of **Mr. Ramit Sherawat**. The booking for the event scheduled on **04.02.2026 from 6:00 PM to 9:00 PM** was made in the names of **Mr. Keshav Hans** and **Mr. Akash Malik**, who had booked the **1 st Floor** of the premises under the name **"World of My Bar."**

It is further submitted that at the time of booking, the said event was represented to us as a private birthday celebration. At no point were we informed, nor did we have any reason to believe, that the said event was connected with any lawyer, advocate, bar association member, or any election-related activity of the Bar Council of Delhi. Our staff and management were also not made aware of the professional background of the said individuals as lawyers or advocates.

We categorically submit that our establishment did not host, promote, permit, or facilitate any election-related gathering, campaign, or party in violation of the directions of the Bar Council of Delhi. Any inference to the contrary may kindly be treated as inadvertent and unintentional.


