**SUBJECT: NOTICE FOR GROSS VIOLATION OF MCC FOR BCD ELECTIONS 2026**

Sir,

It has come to the attention of the Election Committee/Authority that you are organizing a formal gathering on 4th February 2026 at 7:00 PM at the Air Force Station New Delhi (AFND) Golf Course, hosted by one Sq Ldr Sucheta who is allegedly related to you.

The following violations are prima facie established:

Treating and Inducement: Organizing "Pool Side" dinners and cocktails for Advocate-voters constitutes "treating," which is a corrupt practice and a gross violation of the MCC.

Utilizing the official position of a family member in the Armed Forces to secure a high-security defense venue for electioneering is an attempt to exert undue influence over the electorate.

Under the BCD Election Rules, candidates are prohibited from hosting lavish parties or utilizing government/institutional machinery to further their campaign.

You are hereby directed to Cease and Desist from proceeding with this event. Furthermore, you are required to Show Cause by 4:00 P.M. on 04.02.2026 as to why your candidature should not be cancelled and why a reference should not be made to the Disciplinary Committee for professional misconduct.

1. Please refer BCD notice reference number BCD/Elect/2026/162 dated 04.2.2026.





1. I was issued a notice no. BCD/Elect./2026/162 dated 04.02.2026 through Whatsapp on 04.02.2026 therein mentioning that I am organizing a formal gathering on 04.02.2026 at 07:00 PM at the Air Force Station, New Delhi (AFND) Gold Course, allegedly hosted by one of my relative. It was further mentioned that dinner and cocktails for Advocate Voters was being organized, which was prohibited under the BCD Election Rules. I was further asked to cease and desist from proceeding with that event and further I was asked to show cause by 04:00 PM on 04.02.2026 as to why my candidature should not be cancelled and why a reference should not be made to the Disciplinary Committee for professional misconduct.
2. That being a law abiding candidate and having utmost regard for the MCC, I immediately submitted my reply dated 04.02.2026 thereby categorically apprising your good office that neither I have organized any party muchless any cocktail. I have further apprised your good office that the alleged party was being planned without my consent. I have further apprised your good office that the moment I came to know about organizing of any such party, I immediately directed it to be cancelled and accordingly, it was cancelled.
3. That thereafter, I received another notice i.e. BCD/Elect./2026/167 dated 04.02.2026 from your good


office thereby again asking me that in absence of any cogent evidence such as booking, transaction receipts or official cancellation logs, my reply appears to be vague.

4. That in response to the above said notice, I immediately obtained the booking and cancellation proof and forwarded the same to your good office on 04.02.2026 itself.
5. That however, in order to comply with the second notice i.e. BCD/Elect./2026/167 dated 04.02.2026, I am submitting my detailed reply for your kind consideration.
6. That I further reiterate my unwavering respect for your good office and assure that I have never violated MCC for BCD Elections 2026 and can never think even in my dreams to do so. I further assure that I will always be abiding with the Model Code of Conduct for the ensuing election of Bar Council of Delhi in letter and spirit.
