**SUBJECT: VIOLATION OF MODEL CODE OF CONDUCT (MCC) AND MANDATORY
CEASE & DESIST ORDER.**

Sir,

This Committee has received specific and credible intelligence regarding a lavish event scheduled for today evening, 05.02.2026, at the NSCI (Opposite Pragati Maidan). We are in possession of information indicating that "discreet" invitations have been extended to a large number of advocates for the purpose of inducement and voter entertainment.

It has further come to our notice that the booking of the said venue has purportedly been made under some third-party name or proxy. This is viewed by the Committee as a deliberate attempt to evade expenditure limits and escape the scrutiny of the MCC.

Your attention is invited to the BCI Rules, 2023, Model Code of Conduct for BCD Elections 2026 as well as the undertaking/declaration furnished by you, which strictly prohibits:

- o Organizing dinners, lunches, or parties under any nomenclature (Birthday, Bhandara, etc.).
- o The distribution of liquor or gifts to voters.
- o Any act of allurement or enticement, directly or through proxies.
