SUBJECT : PRIMA FACIE VIOLATION OF THE MODEL CODE OF CONDUCT (MCC) REGARDING ILLEGAL DISPLAY OF CAMPAIGN MATERIAL ON PUBLIC PROPERTY.

Sir,

This Committee has taken on record photographic evidence captured on February 4, 2026, at 8:21 PM at D- Block 6th Floor, Lawyers Chamber Block, Karkardooma Court Complex, Delhi -110032. The evidence clearly displays large-scale campaign posters and banners belonging to your respective candidatures fixed onto public civil structures.

The notification dated December 27, 2025, explicitly prohibits the "crude display of money power" and mandates upholding the "nobility and dignity of the legal profession". Furthermore, the BCD advisory dated November 3, 2025, specifically directed the immediate removal of hoardings, banners, and posters.

In exercise of the powers vested in the Election Committee and the Returning Officer to ensure a free and fair election, you are hereby called upon and directed to **APPEAR IN PERSON** for a **Summary Inquiry** at 3.00 P.M on 06.02.2026 at the BCD Office situated at 1-F, Lawyer's Chambers, Delhi High Court, New Delhi - 110003 and explain as to why your candidature should not be CANCELLED / NULLIFIED immediately for this gross breach of the MCC and for attempting to vitiate the sanctity of the election process.

Dear Sir,

It is most respectfully submitted that the Bar Council of Delhi has been pleased to issue the above said Show Cause Notice to the undersigned in relation to the alleged display of promotional posters and solicitation of votes for the forthcoming elections of the Bar Council of Delhi.

In this regard, it is respectfully submitted that the undersigned had neither authorised nor consented to the display of the said poster. It appears that some rival candidates in KKD Courts who have no trust on the fair election contesting procedures and are lacking self-confidence on their own versions have done the said activity just in order to have adverse interference get drawn by your good self-office against the undersigned and with an oblique motive to malign the well-established reputation of the undersigned have committed this illegal act. This act is clear a blatant abuse of process of law and against well establish fair election practice of BCD.

It is further submitted that immediately upon the undersigned becoming aware of the said display, prompt and stern corrective action was taken, and the said poster was forthwith removed from its place of display at the Karkardooma Courts Complex. The undersigned has at all times maintained utmost respect for the dignity of the legal profession and the sanctity of court premises.

The undersigned most humbly assures this Hon'ble Council that clear and categorical instructions have already been issued to all known associates and well-wishers to strictly adhere to and comply with the guidelines, directions, and norms issued by the Bar Council of Delhi from

time to time. The undersigned further undertakes to scrupulously comply with all such directions in letter and spirit in future.

It is submitted with utmost humility that there is no deliberate, intentional, or wilful violation of any rule, regulation, or professional code of conduct, and the incident is purely an act of conspiracy of the rival candidates.

In view of the above facts and circumstances, it is most respectfully prayed that this Hon'ble Council may be pleased to take a lenient view and graciously withdraw the impugned Show Cause Notice, for which act of kindness the undersigned shall remain ever grateful and obliged.
